





# **EXECUTIVE SUMMARY**

Schuylkill River Park plays a significant role in the daily lives of thousand of Philadelphia residents. Because of its central location within the city and its unique amenities this park draws a diverse set of individuals and groups that visit for a multitude of reasons. The paths and places of this park have been the backdrop for many memories and the venues for community building and there are many with a profound relationship to this park that goes back several generations.

The value of this public space is well recognized by the Friends of Schuylkill River Park who have shepherded outreach and public participation for this masterplan document to be developed. With the goal of preserving and maintaining the park as a space for much needed social capital, they reached into the community to ask how park users felt about the park, and how we can all look forward together to build a stronger and more equitable future. The outreach and engagement strategy included public events, one-on-one interviews with stakeholders and park users, and an online survey that invited public feedback. The recommendations that are contained in this document are based on the needs and concerns expressed during this process.

With special attention to identifying opportunities for greater inclusion and increased equity, the projects are divided into short and long term recommendations, and then further divided into discrete projects that can be achieved through various levels of participation and involvement.

The following pages outline how this documents is meant to be used by the Friends of Schuylkill River Park as well as by the community to both maintain and celebrate the existing park successes while prioritizing opportunities for improvement to meet the goals established for the future of the park.

# **Masterplan Methodology**


The objective of this master plan is to learn about the people that use the park; investigate how the design of the park serves their needs; and make recommendations for measures that can be taken to improve the park while promoting it as an inclusive and equitable piece of social infrastructure. The masterplan includes evidence-based recommendations based on feedback received through on-site observations, one-on-one interviews, park events, public meetings and digital surveys.



The information gathered was a mix of quantitative and qualitative data, and the responses offered a wealth of valuable information about the park. Some questions pertained to specific places within the park while others looked at the overall connections and perceptions. Through this we were able to determine how people use and perceive specific spaces and also how those spaces correlate to other spaces with common users. Write-in comments gathered through surveys, one-on-one conversations, and engagement events have been condensed to the common themes and are included under the "what people are saying" section for each project page.

This information has then been compared against the Friends of Schuylkill River Park Board of Directors' overall masterplan goals to determine how effectively these goals are being met and develop recommendations to make them more successful. # **Participant Information**


The park serves a dual purpose as both a neighborhood park for the adjacent communities, but many aspects of the park serve the larger, city-wide community due to its central location, site features and connectivity to the Schuylkill Banks trail. The responses and data provided should be viewed with an understanding that the demographics of those that responded do not represent the demographics of the city of Philadelphia as a whole, but they may represent the demographics of the park users which are a mixture of adjacent neighbors and destination users as described above.

The recommendations contained within this masterplan encourage the Board to think holistically to be more inclusive of individuals shown as being underrepresented. In particular, special attention should be given to making the park more welcoming to people of color.

# **STATE OF THE PARK**

# **Park Overview**

Schuylkill River Park, nestled along the eastern edge of the Schuylkill River, was designed and built in 1976. Owned and operated by Philadelphia Parks and Recreation, it encompasses the green area bordered by the CSX tracks, 25th Street, Manning Street and Lombard Street. It also includes the O'Connor Pool which is not contiguous. The park connects with the Schuylkill Banks Trail via a pedestrian bridge, which was completed in October of 2012. This public green space serves neighborhoods on both sides of the Schuylkill River as a recreational venue for people of all ages. In addition to the amenities outlined below, it contains tree-lined walkways and various seating and social spaces. Schuylkill River Park is heavily used on a daily basis and is well loved by both newcomers and by those that have enjoyed this park for decades.

## Sum of the Parts

The park is a collection of many different programmed spaces, each of which attract different users. Data collected through the masterplan process shows that most visitors use only one or a few of these spaces and do not feel a personal connection to the others. The following recommendations in this document focus on both finding opportunities to improve each individual space but also to find ways to make the park feel more connected and to engender a sense of community across all of the individuals and groups and that use the park.



### **Basketball Courts**

Featuring two full courts, this destination basketball court is heavily used by individuals from across the city.

A contemplative space, this area provides benches flanking a sculpture under the cover of trees. It is used as a meeting location for birthday parties and other small gatherings.



## Playground

Renovated in XXXX, this playground is set to receive additional improvements in the summer of 2020 which include update playground equipment and surfacing.



Two tennis courts sit on the corner of 26th and Pine Streets. They were recently resurfaced in 2016.



### Multi-Purpose Court

This paved area is used for a variety of activities including young children learning to ride bikes. In the past it has been used for bike polo, volleyball leagues, and other organized sports.



#### **Veteran's Memorial**

Small memorial stone and flags erected by local Veterans is a focal point for Veteran's Day celebrations.



### **Markward Recreation Center**

Built in XXXX, this building is the headquarters for the park. Managed by Parks and Recreation staff, it offers classes, after school programs, and summer camps while making the spaces available for community meetings and events. It also contains bathroom facilities that are available during regular hours for the park users.



### **Athletic Fields**

The Schuylkill Pocket Veterans Memorial field is home to Taney baseball, soccer and softball leagues








## What park spaces do you use, and how frequently?





# SHORT TERM GOALS

# that can be accomplished in the next <mark>2 to 5 years.</mark>

The following section contains recommendations for small projects and park improvements that can be made in the short term and will have a high impact for the least amount of financial capital.

The below goals, identified as the most urgent issues and needs for the park, were used to guide these recommendations. Each of the recommendations made aim to accomplish one or more of the goals.

## Short Term Project Goals

- Maintain existing park features while planning for future needs.
- Improve communication and transparency around park programming and opportunities for citizen participation.
- Build capacity and increase involvement.
- Strengthen the sense of a park community across its various interest groups.
- Increase equity and inclusion among users.
- Provide infrastructure to formalize current informal uses.

# **Continued Engagement**

While this masterplan is in response to community input and recommendations are based on needs identified by the park community, continued engagement is required as each improvement project is undertaken to foster communal ownership and stewardship. Based on the survey responses, it is clear that there is a great deal of interest in participating in activities that improve or maintain the park. The map to the right shows the locations of the areas of improvement identified in the short-term recommendations. Five projects are described in detail in the following pages. Each project can be completed as a stand-alone project, or in coordination with another project.



#### Basketball & Multi-purpose Courts

- Unify two spaces with complimentary uses and users.
- Provide new amenities and update existing equipment.
- Formalize existing uses.
- Preserve and add to existing tree canopy.

# **Public Communication**

People are interested in becoming more involved in the park. Whether that is by participating in more events, volunteering their time, donating financially, or just wanting to know more - the feedback received was full of interest to participate.

The greatest barrier to capitalizing on this high level of interest is communicating how individuals and groups can best engage in a way that aligns with their interests and the park's needs. The following recommendations outline physical and digital methods to consider in updating the current communication strategy.

Some components can be accomplished through volunteer board involvement while others may not.

What people are saying...

The primary goal of improving public communication is to make it possible for everyone with an interest in the park to feel a sense of shared pride and responsibility. This will also increase Friends of Schuylkill River Park board and committee capacity to better maintain and make improvements to the existing park.

The below recommendations outline ways to have continual support for regular channels of communication that keep the park community updated and involved. The realization of all of the recommendations of this masterplan will depend on the ability to engage and mobilize the wider park community.

### Recommendations

- Online Presence: Update the website and social media platforms. Consolidate various on-line communication outlets and keep current.
- Open Door Meetings: Publicize public board meetings and share committee and interest group updates.
- Regular Committee Meetings: Organize existing interest groups and volunteer organizations to coordinate with each other through a regular meeting schedule.
- Newsletter: Share news and stories that pique interest, share helpful information and invite people to be a part of the park community. A quarterly newsletter could be emailed and posted in the park for visitors to read. Some things that it could include:
  - Park User Profiles: Recognize and celebrate staff, volunteers and users that make this park unique.
  - Park Highlights: Share interesting or unknown facts about the park that may invite more interest.
  - Volunteer Opportunities: Share volunteer events and committee meeting times and location.
  - Invite Support: Request sponsorship or donations of park improvement campaigns.
- Signage: Locate unified signage at primary entrances and key areas to welcome visitors into the park, share park goals, outline expectations, and highlight participation opportunities to make it easy to become involved.
- Message Boards: Keep park message boards up to date and relocate underused message boards.
- Accept Donations: Set up methods for receiving donations for general or specific purposes.



# Recommendations

- Renovate the basketball courts and multi-court together as a single project with a unifying ground mural to improve existing conditions, formalize existing uses and unify these spaces.
- Improve visibility and connection between basketball, multi-court, and playground to simplify the experience of parents and caregivers.
- Increase the amount of shaded seating throughout.
- Increase the opportunities for play in the multi-court with the addition of low basketball net, wall ball, and integrated trike track and street games incorporated into mural.
- Future engagement and design needs: Organize workshop events on-site to developing ideas for the ground mural. Be sure to include a representative of the basketball user group to increase attendance and make the events as inclusive and welcoming as possible. In order for the renovations to be most impactful, the design needs to be developed in conjunction with all users to foster collective ownership.
- Work with basketball court users to explore possibility of hosting league basketball to increase opportunities for involvement.



Basketball court users utilize the neighboring playground and multicourt regularly. To optimize their experience, these spaces should connect physically and visually.

Install bleacher seating against ramp edge with new shade trees and access from main path.

Install new hoops, nets and backboards.

Work with artist to develop a ground mural to connect basketball and multi-purpose courts.

The dog park is a unique amenity enjoyed by both dog owners and spectators. It is crucial to assure the safety of its users as well as sufficient management of waste.

Opportunities for viewing dogs from outside is both an enjoyable past time as well as a necessity for caregivers that are not able to bring their children inside the fence. In order to make it possible for users to adhere to the posted guidelines, a viewing and waiting area that allows non-disruptive opportunities for dog watching should be provided with visibility to both dog areas.

Physical improvement recommendations are meant to reinforce behavior consistent with being a considerate member of the park community.



- Plant Beds: Install barriers at outside edges to prevent spectators from entering plant beds and interfering with dogs through the fence.
- Designated Viewing Area: Provide opportunity for safe dog watching with close proximity to gates that allows families with children to use the dog park together and follow dog park rules.
- Drainage: Improve drainage and minimize flooding in large dog area.
- Edges: Create barriers to keep dogs in designated play areas only.
- Seating: Provide more shaded seating inside dog park.
- Signage: Develop signage strategy at bowl regarding off leash rules.

#### Suggestions for integration of dog park users with larger park community:

- Include dog park updates in newsletter and distribute at dog park.
- Establish dog park volunteer group and regular cleanup events.
- Organize seasonal dog oriented vendor fair.



Dog park users come from the greatest distances and use the fewest other areas of the park demonstrating that it is an important city-wide destination with low user investment in the park as a whole. Install dog waste receptacle with internal and external access.

Provide seating area to allow dog watching at ground level with visibility from inside the dog area.

Replace trees in existing tree pits and protect all trees from dogs with low barriers.

Provide additional barrier to keep dogs in designated areas.

# **Social Spaces**

While the park already offers a large quantity of benches at the path edges, there are very few opportunities for social interaction or small group gathering.

Gatherings such as birthday parties, fitness classes and informal meet-ups have little support infrastructure.

The sculpture garden is a common place for gathering because of the arrangement of benches in a circle. Both the bowl and the grass area adjacent to the tennis courts are also used for small informal events but require visitors to bring their own tables and chairs. The recommendation of this masterplan is to add flexible seating, picnic tables and other seating opportunities that support small groups in the areas where gathering is already happening.

The addition of new seating types to create more formalized and inviting social spaces can be accomplished incrementally, beginning with low cost furniture to test how these spaces are used. Over time, more investment can be made that directly supports how the spaces are being used.

### Recommendations

**Early Action Seating Improvements:** 

- Picnic Tables: Add inexpensive picnic tables at locations where small gathering is already happening.
- Seating Variety: Explore and add various seating opportunities such as cafe tables, lounge chairs or bench facing configurations to add to edges of the Bowl.

#### **Planting Improvements and Maintenance:**

- Planting: Designated planting areas at entrances, edge of path, around dog park, and at the sculpture garden should be improved and maintained.
- Maintenance Strategy: Develop maintenance strategy to allow park users to manage discrete areas of the gardens or determine need for outsourcing maintenance at an additional cost.

#### Second phase improvements:

- Testing and Feedback: Through a survey or by observing the use of the various seating opportunities in the new gathering spaces FSRP can identify additional needs or potential improvements.
- Higher Investment: Once seating preferences are determined, FSRP can invest in more robust site furnishings based on the needs identified during the first phase of investment.

#### **The Bowl**

Clusters of picnic tables and lounge seating at the edges of the open field allow for increased functionality of the space for formal and informal gathering

#### **Sculpture Garden**

This is a well loved contemplative space that is sometimes used for small gatherings. It is recommended that this space be improved as a garden and other spaces be provided that are better suited for small gathering so this space can function better as a quiet retreat.

# **Community Garden**

The community garden, which occupies a half acre of the park, provides gardening opportunities to nearby residents. Because this amenity is limited to a set number of individuals each year there is frustration and resentment among other park users regarding membership, access to plots, open house hours, garden etiquette and a feeling of exclusion from the garden community.

With an understanding that the plots in the garden are already maximized to allow as much participation as possible and that membership is rotated to allow new members to join, below are recommendations that require less commitment while allowing the same benefits of being a part of the gardening community.


### Recommendations

#### **Communication:**

- Open Hours: Post regular hours that the garden is open to the public staffed with rotating volunteers and community gardeners.
- Plot Access: Post application information to become a plot holder.

#### Planting Improvements and Maintenance:

- Garden Edge: Edit perimeter planting for better visibility.
- Fruit Trees: Plant fruit trees in partnership with an organization such as Philadelphia Orchard Project to provide learning opportunities as well as food access outside the main community garden.
- Adopt-a-Garden: Develop program to allow park users to maintain designated plant areas outside garden.
- Tree Pruning and Removal: Work with certified arborist to develop a plan for increasing light to garden plots
- Tree Replacement: For each tree that is removed, additional trees should be planted elsewhere in the park.



Community gardeners do not frequent other park areas while other park users feel excluded. Priority should be given to bridging those connections in a way that can benefit the users and the park as a whole.

The following recommendations for long-term goals represent improvements that will require significant investment and additional planning. Focusing on the southern portion of the park, these goals represent ambitious aspirations to greatly improve the experience of park users and expand amenities in the following ways:

# Long Term Project Goals

- More space for recreation center year-round and summer camp programming.
- Greater accessibility, visibility and interconnectivity between park areas.
- Equitable access to cooling water in hot summer months.
- Greater opportunity for play.
- Growth and stewardship of natural assets.
- Better infrastructure for athletic programs.



### Playground

- Allow better visual and physical connections between play areas throughout the park.
- Provide more varied play opportunities.



#### **New Rec Center**

- Develop new and larger recreation center to match the needs of the community.
- Relocate building to provide a welcoming entrance into the park as well as functionality for events and camp programming.



### **Athletic Fields**

Update field and athletic infrastructure to meet the needs of multiple sports play.



### Schuylkill Arboretum

- Preserve and protect trees.
- Plan for replacement and addition of new trees.
- Achieve arboretum status and accreditation.



#### **Play Garden**

Provide new nature play opportunities.



### The Plaza

- Develop a central plaza/hub that connects park parts.
- Provide overflow area for events, gathering and play.
- Provide water play to relieve pressure on O'Conner Pool.



### **New Tennis Courts**

Move tennis courts to a better suited area to have better park circulation and more optimal court orientation.



#### **Veteran's Plaza**

- Expanded veteran's plaza at street level to allow space to relocate and formalize the existing memorial.
  - Provide comfortable seating for relaxation and reflection.

This map shows the locations of the areas of improvement identified in the long-term recommendations. Five projects are described in detail in the following pages. While the first three projects are meant to be completed in conjunction, they can be phased or completed as stand-alone projects.

# **Markward Recreation Center**

The recreation center is the heart of the park, but it is confined to the existing small footprint and its presence is often overlooked. Even though it is staffed and operates a variety of programming, most park visitors do not know about them or they do not feel welcome.

The building is frequently used for its bathrooms, and even those are often closed and could receive an upgrade making them easier to maintain. Many of the events or programs do not have ample space within the current recreation center.

The following recommendations provide a longterm goal of developing a new recreation center

# What people are saying...

that functions as an accessible and welcoming public amenity. It should have accessible bathrooms, opportunities for concessions, and a variety of multi-purpose rooms so that the programming can be expanded. Ideally this should be developed in conjunction with the community plaza, new splash pad, play spaces and tennis courts shown on the next two sections as a single project.

# **37%** of comments pertain to **bathrooms being open more often.**

**35%** of comments expressed desire to **update or clean bathrooms.**



- Work with Parks and Recreation to determine limitations and design parameters.
- Develop early feasibility study, and preliminary cost estimate for new recreation center.

Implementation

- Launch capital campaign for partnership opportunities and fundraising efforts.
- Solicit design team proposals that includes a robust community engagement process to build off this master plan.

The existing recreation center does not operate as a park anchor. It has correlations to the playground, but not the other active parts of the park.



# **Markward Entrance Plaza and Play Areas**

The playground is a primary draw for many people that visit the park and has the highest number of regular visits. It is also located at the park entrance that sees the most use. Many responded to the survey indicating that the existing playground serves their needs as it is now, but there is still a desire for expanded play opportunities to manage large visiting groups and younger children.

Parks and Recreation is currently undergoing designs for renovations to the playground and entrance plaza, so any significant changes to this area should be planned for the long term and in conjunction with the redevelopment of the Markward Recreation Center (outlined on previous page).

Recommendations for redeveloping this outdoor play area and plaza are centered around providing more comfort for caregivers, diversity in play opportunities and better connections between the play spaces, the rec center, and the rest of the park.

# **Athletic Fields / Tennis Courts**

The Athletic fields are regularly used by Taney Baseball, Soccer and Softball leagues and are locked the remainder of the time to maintain field condition. This practice is viewed as exclusionary by individuals that wish to use it for pick-up games but do not feel welcome to do so. The fields are in need of regrading to help with drainage issues and to maintain the turf.

The tennis courts are also well used but there is some confusion around how and when the courts can be used, and what the protocols for use are. The tennis courts have been recently resurfaced but there are many complaints about the surface and the equipment. In addition, there is not a place where people can wait to play a game.

Below are recommendations that should be completed in correlation with the previous sections on the new rec center and entrance plaza.





# Schuylkill Arboretum

The mature trees of Schuylkill River Park are very appreciated and give the park much of its character. However, there is no current plan for the for the selection and planting of the next generation of canopy trees that will preserve this character after the existing trees reach the end of their life. It is recommended that the Friends of Schuylkill River Park commission a tree inventory and arboretum plan in accordance with the guidelines outlined by ArbNet as a first step in achieving level I arboretum accreditation. This masterplan serves as an interim guide to help structure the goals and purpose behind the arboretum and can be used to direct tree planting in the short term in a way that will support an overarching arboretum vision. Broad criteria are outlined for selecting plants within specific regions of the park to support park function and reinforce the sense of place.

### Recommendations

#### **Additional Planning:**

- Commission a tree inventory and assign accession numbers to catalogue the existing collection.
- Commission an arboretum plan in accordance with the criteria according to ArbNet. org for obtaining level I accreditation as an arboretum.

#### **Short Term Planting and Improvements:**

- Plant new trees and shrubs in conjunction with short term park improvements that support the proposed improvements and are in line with the broader goals identified in this section of the masterplan.
- Commission a certified arborist to identify existing trees and provide tree labeling with scientific and common names.
- Delay replanting of trees where existing trees have died in areas where long term improvements are planned that would conflict with those tree locations.
- Preserve all existing trees until they reach the end of their life or conflict with a larger improvement project.

#### **Community Garden / Orchard**

Planting of any new trees in this area need to be carefully considered for potential impact on sunlight in the garden plots. Selection of the trees for the fruit orchard should be in conjunction with the development of an orchard management and maintenance plan that will be administered by the community garden members.

#### **Informal Allee**

Use tree planting over time to reinforce the primary pathway of the park. Trees should not be of identical species but should be selected to create the effect of a tall canopy allee. Infill new trees around mature trees to take their place as they become over-mature and begin to die out. Plant on regular spacing when possible.

#### **Shade Canopy**

Trees in high use program areas should be selected for high canopy and quality of shade. These trees should be native species, or native cultivars when practical but the primary considerations should be suitability to urban conditions.

#### **Arboretum Core**

This area of the park has the most potential for additional planting and has the most need for new trees to be the next generation of canopy. It is recommended that plants should be selected to highlight native species and provide food and habitat for native fauna. Maintaining site lines across the park for safety is a primary consideration for plant selection and placement.

#### **Sensory Garden**

This should be developed as a children's garden to foster a love of native plants and to highlight plants that are fragrant, colorful or have tactile qualities.

# **O'Conner Pool**

The O'Connor Pool, while not contiguously connected, is a part of Schuylkill River Park and managed by the Markward Recreation staff during the summer season. It is heavily used and a large part of summer memories for many nearby residents.

Given the popularity and demand for the pool in the summer months, we recommend relieving pressure by adding additional water features closer to the recreation center. This would allow the opportunity to extend C

the survey, it should be noted that the engagement for this masterplan plan took place outside the pool season without access to area to complete an evaluation. Therefore additional engagement with pool users and stakeholders to develop any improvement strategies is needed. The retaining wall at the western edge of the pool will be receiving repairs after a structural study has been completed in 2020, but no additional improvements are planned for the pool at this time.


## Recommendations

#### **Increased Water Play Opportunities:**

Create a sprayground at the redeveloped Markward Plaza to provide an alternative to the pool for cooling off and to relieve some of the overcrowding and lines at the pool.

#### **Pool Infrastructure Updates:**

- Upgrades to the retaining wall and pool infrastructure should be prioritized to create a safe and enjoyable swimming experience.
- An expansion of the provided beach chairs, planters and shade structures can make the pool experience more comfortable.
- Provide street trees at edges of pool for shade during times when there is a line to access the pool.














#### MEETING MINUTES

The purpose of this meeting was to convene a large group of stakeholders that represent the range of organizations and individuals that use the park or have an interest in the development of the park or have insight into factors that would impact any future improvements.

#### Introduction

Hinge Collective (Hinge) invited everyone in attendance to introduce themselves, their relationship to the park and why they decided to be on the board. Board members also shared their favorite memories of a time spent in SRP which influenced a later portion of the conversation.

Hinge shared base line master planning goals. The master plan should act as a:

- Visioning Document that the BOD can aspire toward.
- Framework for future improvements so as to coordinate efforts to strategically use resources and increase efficiency.

#### Masterplanning Process

Hinge stated that the masterplan will contain both long-term aspirational goals and short-term "bits-size" incremental improvements that can happen with smaller funding requirements. Projects such as the dog park and pedestrian bridge over the rail are successful past examples of long-term projects requiring large funding sources already shepherded by the SRP BOD.

SRP Mission Statement "Friends of Schuylkill River Park is a non-profit organization. It was formed in 1988 by concerned neighbors to foster the preservation, beautification, improvement, maintenance, and enjoyment of Schuylkill River Park."

Based on a discussion, the following elements were determined to be important for SRP specifically.

- A plan that is responsive to collective needs of the park community, has broad support and builds participation and membership/capacity
- It should identify and understand the SRP community

- Who is using the park? Where are they coming from?
- How the park is currently serving the community well and what it could be done better?
- What is the collective understanding of the park community?

- Evoke favorite memories to understand what makes this particular space memorable.

#### **Project Schedule**

Because it is already September, Hinge Collective and the BOD will prioritize engagement and outreach efforts that were to take place in the park asap before the winter months made it more difficult to conduct interviews. The fall and early winter months will be used to gather feedback and the plan will be developed early 2020.

#### Goal Setting Workshop

Hinge facilitated a goal setting workshop to identify the park community, park successes, and set goals for what would like to be achieved in this plan. The discussion follows:

### What do you think is working well? What parts of the park would you consider sacred and want to be left untouched?

- Shade the trees in this park are highly appreciated. They should be a priority.
- The bowl it is a flexible open space that can host a variety of events
- Multi-purpose court the paved area between the playground and basketball court was mentioned as the location for many of the "favorite memories" at the beginning of the meeting. It seems unassuming but is frequented by many neighbors.
- Playground it received renovations recently, it is slated to receive more, and is a very good playground.
- Dog Park with the exception of some cosmetic improvements, the dog park is already a successful destination area that draws people from all over the city
- Community Gardens There is active leadership and it is maintained well.
- Baseball and Soccer Fields These spaces are popular and see a regular schedule of programmed activity occurring on them.
- Pool this is one of the best pools in the city and is in high demand during the season
- Tennis Courts with the exception of the new surface, the tennis courts are used and appreciated
- Pathways the paths are in good condition and cover the area that they should

#### MEETING MINUTES

The purpose of this meeting was to convene a large group of stakeholders that represent the range of organizations and individuals that use the park or have an interest in the development of the park or have insight into factors that would impact any future improvements.

#### Introduction

Hinge Collective (Hinge) invited everyone in attendance to introduce themselves and their affiliation or relationship to the park.

Hinge stated the goals of the meeting as an opportunity to share the community input that had been gathered to date and to use that input as starting point for a group discussion about the park as a whole and its individual parts. Hinge also stated that the stakeholders will also have an opportunity to identify strategic partnerships and opportunities for collective support of improvements identified in the forthcoming masterplan.

Hinge shared information gathered through a park user survey as well as information gathered through an engagement exercise at the Fall Festival on October 19<sup>th</sup>. Hinge noted that all information presented at the meeting is incomplete because input is still being collected and there are some groups that may require special attention to ensure equal participation. With this caveat stated, Hinge related the key takeaways from the engagement and discussed them with the stakeholder group in attendance. Key takeaways that related to the park overall included the following points:

- Many people have a long-standing relationship with the park that spans generations.
- The park is well used and well loved.
- Better communication is needed to spread awareness of the existence of the Friends group and of
  ways that community members can contribute to the development and upkeep of the park. Better
  communication regarding events is also needed.
- The park seems to be the lease accommodating of teens and elderly.
- The park is very welcoming to most people and many people feel a sense of ownership over the park.
- The park is viewed as being a very safe place to be.
- Most people enter the park at the Markward entrance and the Spruce St entrance.

Hinge then opened up the discussion to the larger group, prompting the discussion by sharing survey comments about each individual park space.

#### Stakeholder Discussion of Park Areas

The following is a record of the Stakeholder discussion on each area of the park as well as action items for additional follow-up:

Markward Rec Center	<ul> <li>The building could be more open, connected to the outside and welcoming.</li> <li>The potential for concessions at the rec center should be explored. Barbera Halpern from CCRA mentioned that CCRA might be able to help facilitate inclusion of concessions.</li> <li>There is already not enough space for the current programming at the rec center.</li> <li>The bathrooms need renovation and they are frequently not open. Many responses to the survey asked if they could donate money directly to the bathrooms. Megan Funk from PPR did not know the answer but will confirm.</li> </ul>	<ul> <li>Follow up with Barbera H. at CCRA regarding concessions.</li> <li>Follow up with PPR regarding potential for concessions as well as donations for specific improvements or staff time to keep bathrooms open.</li> <li>Identify short term for bathrooms and long-term goals for more ambitious overhaul of the building.</li> </ul>

The arrangement with TPS of the yard could be revisited or revised to minimize this conflict. This issue was noted in many of the survey comments as well.</li> <li>The playground is due for upgrades in the short term. Any recommendations in the masterplan for this area will be long term.</li> </ul>	<ul> <li>Follow up with TPS regarding an informal agreement and make sure that proposed changes to the playground in the masterplan are responsive to any potential future arrangements.</li> <li>Identify this as a long-term project in the masterplan.</li> </ul>
Multi-court	<ul> <li>This area is well used and well loved.</li> <li>There was a survey comment asking for more separation from the Basketball courts. A neighbor, and frequent user of the basketball courts believed that this comment was in regards to a desire to be farther from the people who play basketball and she suggested that there should be less separation, not more, to build better relations between the basketball court users, who are predominantly black, and those who use the multi-court, who are predominantly white.</li> <li>There was support for an idea to incorporate a mural on the ground surface that could unify the basketball courts and multi-court.</li> <li>There was support for the idea of adding additional seating and shade in this area.</li> <li>Ideas for including painted games on the ground as well as backboards for handball and other games was well received.</li> </ul>	<ul> <li>Include mural idea in the draft masterplan and vet through frequent users of the Basketball courts and the multi-court.</li> <li>Identify this area as a short term project in the masterplan.</li> </ul>

Basketball Courts	<ul> <li>This user group is underrepresented in the survey and at the stakeholder meeting. More effort is needed to get input from this group and make sure their voices are heard.</li> <li>Upgrades to the courts and baskets is seen as a good short-term improvement.</li> <li>Including a hoop that lowers to allow kids to play here was suggested by both the survey responses and those at the stakeholder meeting.</li> <li>There was a suggestion to include a half court basket so that more people can use the courts when full court games are going on both courts.</li> <li>There was interest in hosting a league, but parking issues would need to be addressed first.</li> <li>There was a suggestion to include bleacher seating.</li> </ul>	<ul> <li>Set up a meeting with basketball court users.</li> <li>Spend time at the court and interview those using the space during peak hours.</li> <li>Perform more outreach to get more survey responses from people who use the basketball courts.</li> <li>Identify this area as a short term project in the masterplan.</li> </ul>
Tennis Courts	<ul> <li>There was a suggestion to include bledcher seating.</li> <li>There was support for the idea of a message board to better communicate sign up for play.</li> <li>There was discussion around whether the courts could be reserved. Many objected to the idea of there being a fee to play or to reserve the courts. There was some support for the idea that some hours could be reserved for private lessons.</li> <li>The new surfacing is not good and should be replaced or repaired if possible.</li> <li>The current courts are at the wrong orientation.</li> <li>There was a suggestion to explore adding additional courts and re-orienting them.</li> <li>The fence needs vine clearing and repair.</li> <li>The existing grass area that is used as a waiting area for those in line to play is also used for occasional children's programming and birthday parties. If this area is to be developed as a better waiting area, it should be multifunctional for the existing uses.</li> <li>There was support for the idea of adding a backboard for hitting practice during non-peak hours.</li> <li>It was noted that the tennis courts may be located on top of contaminated soil.</li> </ul>	<ul> <li>Explore ideas for adding and re-orienting courts as a long term goal in the masterplan.</li> <li>Include low cost improvements to make the waiting area function better for tennis and for other small events in the short term.</li> </ul>

Dog Park	<ul> <li>Watching dogs is a favorite activity in the park. Watching from up above on the pedestrian overpass is great for dogs and people. Watching dogs on the ground through the fence is disruptive to dogs and is potentially dangerous to children. More opportunities for viewing dogs in the park from a safe distance should be explored.</li> <li>There are no trash cans for poop bags inside the park because PPR will not go in to the park to pick up bags for safety reasons. The current system is not working and results in poop bags being everywhere in scattered around the trash cans outside the fence because they are thrown. A new solution for this should be explored.</li> <li>There ares support for more places to sit in the shade.</li> <li>There was also confirmation that the posted rules are not followed. The garden cannot be open unless there is a gardener present to make sure that no produce is taken without permission.</li> <li>There is some confusion about how one obtains a garden plot and when the garden is open to the public.</li> <li>More can be done to make the community garden feel more open to the public.</li> <li>There was a request for pruning of the trees for more light.</li> </ul>	<ul> <li>Identify opportunities for better communication about the community garden and increasing the public nature of this space.</li> <li>Include a recommendation for a pruning schedule to allow for more light.</li> <li>Request shade study recently performed by community garden club.</li> </ul>
Athletic Fields	<ul> <li>Drainage issues were mentioned by both those responding to the survey and a stakeholder.</li> <li>There was a response to survey comments regarding public access. There was concern that removing any physical barriers might encourage more dog walking on the field.</li> </ul>	Include a recommendation for regrading the infield of the baseball field for better drainage.

O'Conner Pool	<ul> <li>There is concern regarding the integrity of the retaining wall currently for the pool, and an engineering study is currently underway.</li> <li>The pool creates "dead zones" on the block where it is located that is a place where crime occurs.</li> <li>Many agreed that this is not an ideal place for the pool</li> <li>After the official end of the meeting there was a suggestion made that the pool could be relocated to be within the limit of the park. While this is an ambitious project, it would solve many of the issues with the current pool.</li> </ul>	<ul> <li>Follow-up regarding the wall study.</li> <li>Explore the feasibility of relocating the pool on the park grounds.</li> </ul>
